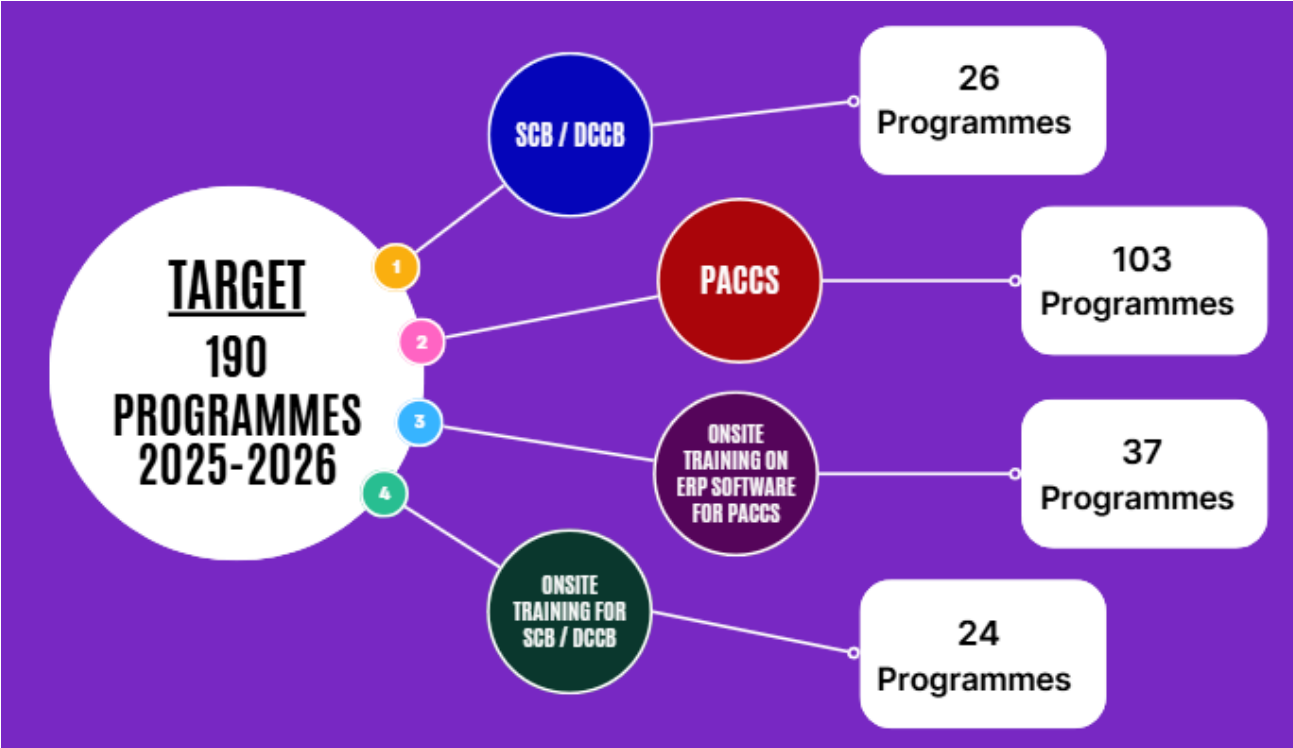

# FIELD VISITS

As part of our training curriculum, field trips are organized for participants across various programmes to provide hands-on exposure and deepen their understanding of cooperative functioning.

Under the Training Programme on Accreditation of Warehouses and Financing Against NWR held from 28.04.2025 to 30.04.2025 conducted for the Staff of PACCS, participants toured the Tamil Nadu Civil Supplies Warehouse at Madhavaram on 29.04.2025. The warehouse supervisor provided an in-depth explanation of warehouse operations, maintenance procedures, and the various registers maintained for efficient functioning.

Similarly, under the Programme on Women's Empowerment held from 23.06.2025 to 25.06.2025 for the staff of PACCS. The participants visited the Panapakkam Kolar PACCS in Ponneri on 24.06.2025, Thiruvallur district. They engaged in a fruitful discussion with the PACCS Secretary and reviewed different registers and accounting records to better understand the society's activities.

In the Programme on PACCS as Farmers Producer Organisations held for the Staff of PACCS from 23.06.2025 to 25.06.2025. The participants were taken to the Gummidipoondi Black Farmers Producer Society on 24.06.2025. The visit included

a tour of the agricultural fields, offering a close view of crop production processes and marketing practices. The General Manager of the society explained how agricultural produce is marketed and outlined the commission structures followed.

The Programme on Project Appraisal of Farm and Non farm loans held for the Staff of PACCS from 16.06.2025 to 19.06.2025, the participants visited the Muthialpet PACCS at Kancheepuram on 18.06.2025. The visit included an inspection of the PDS shop and the medical store operated by the PACCS. Participants engaged in detailed discussions with the management, gaining valuable insights into the day-to-day functioning of these units.

In the Programme on the Role of Circle Supervisors and Field Managers held from 24.06.2025 to 27.06.2025 for the SCB / DCCBs. The participants were taken for field visit to the Heavy Vehicle Factory Employees' Cooperative Society at Avadi on 26.06.2025. During the visit, they gained valuable insights into the society's operations and examined the various books of accounts maintained. The Secretary of the society provided a detailed briefing on its functioning.

These visits not only broadened the participants' practical knowledge but also strengthened their appreciation for the cooperative movement's grassroots impact.



## **NABARD Officials visit for Half yearly Inspection :**

The National Bank for Agriculture and Rural Development (NABARD), as the apex institution overseeing the cooperative credit structure and rural development initiatives, periodically undertakes official visit to the training Institute. These visits, conducted on a quarterly basis, play a vital role in ensuring accountability, transparency, and adherence to prescribed norms.

During the quarterly visit, NABARD officials, Ms. Rayudu Saipadmini and Ms. Nayana S Nair, carried out a comprehensive inspection of the claims submitted by the institution for reimbursement or financial assistance under SOFTCOB policy. The verification process includes checking the authenticity of claims, assessing supporting documents, and ensuring compliance with guidelines laid down by NABARD. This exercise not only safeguards institutional funds but also ensures that financial benefits reach the intended beneficiaries in a fair and efficient manner.

In addition to financial claim verification, NABARD officials also examined the training records maintained by the institution. Training programmes form an integral part of strengthening the cooperative sector, as they enhance the skills and knowledge of employees.

During the inspection, officials review attendance registers, training modules, feedback reports, and evaluation mechanisms. This scrutiny ensures that the programmes conducted are relevant, effective, and aligned with NABARD's / C-PEC BIRD Lucknow objectives.

The quarterly visits thus serve a dual purpose i.e ensuring financial propriety on one hand and enhancing the quality of training and institutional development on the other. The observations made during these inspections helps to identify gaps, provide corrective suggestions, and guide institutions towards improved performance and governance.

## **National Cooperative Policy – 2025**

- What is it?
  - The National Cooperative Policy 2025 is a forward-looking, result-oriented policy designed to institutionalise, expand, and modernise India's cooperative sector as a key pillar of economic growth and social equity.



- Objective:
  - To triple the cooperative sector's share in GDP by 2034.
  - Ensure active participation of 50 crore members.
  - Establish at least one cooperative in every village.
  - Enhance transparency, financial sustainability, and digital integration.
  - Empower rural women, tribals, Dalits, and youth through cooperatives.
  - Build a self-reliant and employment-rich cooperative ecosystem by 2047.
- Key Features of National Cooperative Policy 2025:
  - Inclusive and Village-Centric Focus:
    - Core emphasis on villages, agriculture, rural women, Dalits, and tribals.
    - Aim to create 5 model cooperative villages per tehsil.
    - PACS to serve as anchors for rural service delivery (e.g., Jan Aushadhi, LPG, Water Schemes).



- **Expansion and Modernisation of Cooperatives:**

- 30% rise in number of cooperative societies.
- 45,000 new PACS under implementation.
- New cooperatives to be launched in taxi, tourism, green energy, and insurance sectors.
- Launch of ‘Sahkar Taxi’ initiative to ensure driver-centric profit models.

- **Digital Transformation & Transparency:**

- Computerisation of PACS and adoption of tech-enabled governance
- Cluster-based monitoring and real-time data systems for accountability
- Legal provisions to be reviewed and updated every 10 years .

- **Youth and Women Empowerment:**

- Employment and skilling through Tribhuvan Sahkari University.
- White Revolution 2.0 to boost dairy and women’s cooperative participation.
- Promotion of cooperative entrepreneurship among youth in new sectors.

- **Sectoral Diversification:**

- Entry into tourism, logistics, insurance, and green energy through cooperatives.
- Establishment of three multi-state cooperative societies:
  - National Cooperative Exports Ltd
  - National Seed Cooperative
  - National Organic Products Marketing Cooperative

- **Sustainability and Global Outreach:**

- Use of environmental principles and circular economy in operations.
- Global access through National Cooperative Export Limited.
- Participation in International Year of Cooperatives with grassroots execution.
